2017/ 2018 PARENTAL / GUARDIAN PERMISSION AND WAIVER

1. PERMISSION TO PARTICIPATE: I, the parent/guardian of the above named participant hereby acknowledge that my child is in good general health and I give my approval for my child to participate in any and all **COYRC** national, regional, league/conference, association and team/squad activities, including transportation to and from the activities by a licensed driver with proof of insurance.

2. INTENT TO INFORM: I acknowledge that I am fully aware of the potential dangers of participation in any sport and I fully understand the participation in rugby may result in **SERIOUS INJURIES, PARALYSIS, PERMANENT DISABILITY AND/OR DEATH**. Furthermore, I fully acknowledge and understand that protective equipment does not prevent all participant injuries, and therefore I do hereby waive, release, absolve, indemnify, and agree to hold harmless the local, league, regional and national rugby organizations and any and all organizers, sponsors, supervisors, coaches, trainers, managers, **COYRC** Board Members, participants, and persons transporting the above named participant to and from activities, from any claim arising out of any injury to my/our child whether the result of negligence or for any other cause.

3. EMERGENCY MEDICAL AUTHORIZATION: I hereby grant my permission for any and all emergency medical/dental treatment and/or first aid to be administered to my child/participant, including authorizing any medical treatment facility/hospital to administer emergency treatment, for any illness/injury/accident resulting from participation in any and all **COYRC** activities.

4. EQUIPMENT RESPONSIBILITY: I agree to assume full responsibility for any and all equipment/uniforms of my child/participant and agree to maintain it in good, presentable and workable condition.

5. SCHOLASTIC VERIFICATION: I hereby stipulate that my child is scholastically fit and that my child is currently enrolled and attending school, and that my child will maintain a minimum, and current, 2.0 GPA during participation with the **COYRC**. Furthermore, I hereby authorize my child's school to release school grades, grade checks, report card results, and any and all other pertinent scholastic information to the **COYRC** in order to verify compliance with these requirements.

6. FINANCIAL RESPONSIBILITY: I hereby stipulate that I have been advised by the **COYRC** of my rights, if any, to a refund in accordance with the **COYRC** policies.

7. CODES OF CONDUCT: In order to uphold the goals of **COYRC** and ensure all participants have the benefit of a safe and fun environment, all players, parents, guardians, coaches and other attendees must behave in accordance with the following Codes of Conduct:

A) Player Code of Conduct

I play for the love of rugby and will strive to be a good ambassador for **COYRC**. I will represent **COYRC**, its coaches, parents, fellow players, and league with responsible and sportsmanlike behavior on and off the field. I will refrain from using profanity, engage in "dangerous play" or any behavior that would adversely affect **COYRC**, the league or sport itself. I will never argue with, insult or threaten a referee, coach, player, or spectator. I will encourage the same behavior in fellow players. I will respect all opponents while striving to win with humility and lose with grace and dignity. I will participate in all mandatory practices and games, or will notify my coach if unable to attend. I will follow all guidelines for **COYRC'S** team travel as outlined in the travel policies. I understand a Referee will abandon the match if any Match Official (Referee, Touch Judge, Field Monitor or other assigned official) is threatened verbally or physically. I will abide by all posted rules governing the entrance to, and use of fields, facilities and amenities at all practice or game facilities. I acknowledge **COYRC's** Policy on Drugs, Alcohol and Tobacco, and that any violation will result in a meeting with **COYRC** Coaching Staff and parents/guardians to discuss potential disciplinary action. I acknowledge **COYRC's** Zero Tolerance to Violence Policy for overt and blatant acts of un-sportsmanlike behavior. A player who engages in such conduct before, during and after match play will be subject to potential disciplinary action by **COYRC** Coaching Staff. Any player caught in the act of violence during a game, or away from the Referee's line of site, will be removed from the game immediately for a cooling off period. If the behavior continues, or player is disrespectful to the coach, the player will be pulled for the game entirely and serve an additional one game suspension. I understand Coaches will notify the Coach Coordinator and Chico Oaks Youth Rugby Club Board of Directors of any verbal disciplinary warning given to a player before the next practice or game, whichever comes first. Due process will be given for parents, players and coaches at a specified board meeting upon request to dispute disciplinary action. I agree to abide by the Nor Cal Youth Rugby Association Code of Conduct and the **COYRC's** Player Code of Conduct. Failure to abide by this Code of Conduct will result in disciplinary action that could include but is not limited to: a) Verbal warning, b) Written warning, c) Game suspension, d) Season suspension, and e) Expulsion from the league with possible legal action.

B) Parent, Guardian, Attendee Code of Conduct

I will not force my child to participate in rugby, and will encourage my child to play by the rules. I will inform the coach of any physical or mental disability that may affect the safety of my child or others. I and my guests will encourage sportsmanship, respect and courtesy for players, coaches, referees, and other spectators. I and my guests will not engage in unsportsmanlike conduct or any other behavior that would endanger the health and well-being of the athletes, coaches and referees. I and my guests will refrain from entering the field of play and stay behind ropes the entire length of the game. I will not use profane language, or ridicule or yell at my child or another participant. I will emphasize fair play, respect, and the spirit of competition over winning as the only objective. I will abide by all posted rules governing the entrance to, and use of fields, facilities and amenities at all practice or game facilities. I will refrain from coaching my child and other players during games and practices unless I am an official coach of the team. I will follow all guidelines for Chico Oaks Youth Rugby team travel as outlined in the travel policies. I understand a Referee will abandon the match if any Match Official (Referee, Touch Judge, Field Monitor or other assigned official) is threatened verbally or physically. I understand Coaches will notify the Coach Coordinator and Chico Oaks Youth Rugby Club Board of Directors of any verbal disciplinary warning given to a player before the next practice or game, whichever comes first. Due process will be given for parents, players and coaches at a specified board meeting upon request to dispute disciplinary action. I agree to abide by the Nor Cal Youth Rugby Association Code of Conduct and the **COYRC** Parent, Guardian, Attendee Code of Conduct. Failure to abide by this Code of Conduct will result in disciplinary action that could include but is not limited to: a) Verbal warning, b) Written warning, c) Game suspension, d) Season suspension, and e) Expulsion from league with possible legal action.

C) Coach Code of Conduct

I shall master contest rules and teach them correctly to players. I am aware that I have tremendous influence, for good or ill, and shall never place the value of winning above instilling the highest ideals of character. I will teach respect for the game of rugby and endeavor to teach the love of rugby and its honorable traditions. I will represent my team, fellow coaches, players, league and game of rugby with responsible behavior on and off the field. I will never physically or verbally, intimidate, assault or threaten a referee, player, coach or spectator. I will never use obscene language and gestures. I will abide by all posted rules governing the entrance to, and use of fields, facilities and amenities at all practice or game facilities. I will be responsible with alcohol consumption, and will not be in an inebriated state at or during practices, games and other competitions. I will not knowingly allow a player to be included on a roster or play in a game that is not eligible to play. I will follow all guidelines for Chico Oaks Youth Rugby team travel as outlined in the travel policies. I understand a Referee will abandon the match if any Match Official (Referee, Touch Judge, Field Monitor or other assigned official) is threatened verbally or physically. I acknowledge Coaches will notify the Coach Coordinator and Chico Oaks Youth Rugby Club Board of Directors of any verbal disciplinary warning given to a player before the next practice or game, whichever comes first. I acknowledge Coaches are responsible for setting the standards for sportsmanship amongst players. A "Zero Tolerance to Violence" approach shall be in effect for overt and blatant acts of un-sportsmanlike behavior whereby a player(s) who engages in such conduct before, during and after match play will be subject to potential disciplinary action by COYRC Coaching Staff. All Coaches upon witnessing violence during a game and away from the Referee line of site, *must* pull that player for a cooling off period, if the behavior continues or player is disrespectful he/she will be pulled for the game entirely. Due process will be given for parents, players and coaches at a specified board meeting upon request to dispute disciplinary action. I agree to abide by the Nor Cal Youth Rugby Association Code of Conduct and the COYRC Coaches Code of Conduct. Failure to abide by this Code of Conduct will result in disciplinary action that could include but is not limited to: a) Verbal warning, b) Written warning, c) Game suspension, d) Season suspension, and e) Expulsion from league/possible legal action.

8. ELGIBILITY: I understand that my child must meet the **COYRC** requirements in order to participate in any and all **COYRC** programs and events.

9. RULES AND REGULATIONS: I hereby understand and acknowledge that as a player or parent/guardian of a **COYRC** participant it is my responsibility to comply with all the rules and regulations stipulated, adopted or recognized by the **COYRC** or any of its member or affiliate organizations, including but not limited to the Player/Adult Code of Conduct, and the **COYRC** Player/Parent/Coach Handbook. Non-compliance with any and all rules and regulations may be cause for discipline and/or dismissal of my child/the participant, myself, and/or any spectators or other persons affiliated with the undersigned and the above named participant.

10. PHOTO AND MEDIA: I hereby give my consent for the **COYRC** to use my child's photograph and likeness to be used in its publications, including its website. I release them from any expectation of confidentiality for the undersigned minor children and myself and attest that I am the parent or legal guardian of the children listed below.
